Mayor's Message

As most of you know, the city has for many years been working to resolve development issues that have arisen over Dr. Wendell Gibby's proposed subdivision on the lower portion of Maple Mountain. Development issues are always challenging, but because of the unique nature of this particular property, the process has been more complex and difficult than most. You may have heard that recently the city received a significant and favorable court ruling regarding this development. Because so many questions remain, however, I'm devoting this month's message to bringing residents up to date on this project.

You will recall that in the hope of reaching a comprehensive settlement agreement resolving all issues between the city and the property owner, city officials last year entered into a Memorandum of Understanding (MOU) which was approved and signed by both Dr. Gibby and the city. Because of the importance of resolving several pending lawsuits against the city, we have worked tirelessly since the MOU was signed in May of 2007 to fulfill all of the obligations the city took upon itself under this MOU. It is impossible to quantify the hours that have been devoted to this cause. I am grateful to all the dedicated members of the Planning Commission, City Council, and the legal, administration, engineering, and planning staff that have spent so much time trying to work through the issues, and accomplish everything the city had resolved to do.

Because of the intense efforts, the city was able to fulfill all of the initial commitments it had made in the MOU by late spring of this past year. Dr. Gibby, however, disagreed, believing the city had not accomplished everything necessary to trigger the dismissal of all of his lawsuits against the city. Because we were strongly confident we had, in fact, completed these necessary requirements, the city filed a Motion to Enforce the initial terms of the MOU in the district court. That motion was successfully litigated during late October and early November of this year. I am pleased to report that on December 12 at about 4 p.m., the city received notification of a ruling issued in the case. That ruling found in favor of the city's position and awarded attorney's fees to the city.

The city is now working to prepare a response to the ruling which will lead to the issuance of a final order in the case. We anticipate receiving the order in approximately February of 2009. It is possible there might be an appeal of the case, so we can not yet assume this will be the end of the process. Still, it is a very important first step and we are very grateful to have reached this critical milestone successfully. The city remains committed to continuing to work with Dr. Gibby to finalize his development and end all disagreements over the development of his property.

Although many residents have expressed a deep wish that the mountain could remain an unchanged, beautiful, and peaceful landmark representing the beauty and high quality of life in our town most also accept that no one can control property they do not own. Many are coming to understand that Dr. Gibby certainly does have the right to develop his property, as long as it is in compliance with the law. It's important to note that so far, everything that has occurred on the mountain has been, to the best of our knowledge, in compliance with all city laws.

There have been many questions about the road that has been cut well up the face of the mountain. This road has been one of the very complex issues the city has tried to work through. As you are probably aware, one of the requirements of the MOU was for the city to give Dr. Gibby permission to move the powerlines that currently run across the flat area of his property to a location higher on the mountain. As the property owner, his desire to move the lines is understandable, as their present location interferes with the most desirable portion of his property. Moving the lines will enhance the value of the future homesites on the property, and the city has affirmed Dr. Gibby's right to move those poles and lines. Rocky Mountain Power is also willing to support the relocation of the lines.

In order to accomplish this, Dr. Gibby applied to grade an access road to facilitate the movement of the lines. Although the city was several times given conflicting information from Rocky Mountain Power regarding the need and their approval for this access road, RMP did, on June 4, 2008, sign a document confirming the road should be built in order to facilitate the engineering of the power line movement. However, shortly after signing this document, they reversed this position verbally, creating confusion for all the parties. Since there was no further *written* direction from them, confusion remained. It was not until testimony in court solidified the situation that the city felt it must rely on RMP's last written position as the final word on the matter. Consequently, it was determined grading of the access road should not be prevented. Grading a "required access easement" is one of only four conditions of the PD-2 zone adopted by the city council in September of 2007 that allows for grading to occur on the slope areas of this property. Since the written document from RMP stated the access road was required, the grading was allowed to commence.

While the city would have preferred the road not be constructed until after Rocky Mountain Power had undertaken their engineering study to confirm it's appropriate location and design (which RMP had repeatedly assured us was the proper sequence to follow,) the Rocky Mountain Power written document effectively removed that option. Recent events and resulting conversations with RMP have further clouded things, and even now RMP's position remains a little contradictory and unclear to us. But the reality is the road is already in place. As part of the city's legal commitment to assist Dr. Gibby in his development efforts, the city will not interfere with this road and it will remain. If a significant future occurrence changes the legal status of this road, we will cross that bridge when it arrives. At this time, we do not have any reason to believe such a compelling change will occur. We take comfort from the fact Dr. Gibby will re-vegetate the area as soon as practical. Hopefully the road will, over time, be less visible and intrusive on the landscape. But please understand the poles themselves will eventually be moved to the same approximate location as the road.

When the property is developed under the current plan, it is hoped there will be minimal visual impact from the 47 new homes as they will be located on the relatively flat area and not extend up the hillside. The city is waiting for the submission of final drawings which will indicate what, if any, further issues remain to be resolved. There will be adequate public notice prior to consideration of those final drawings. I hope that all interested parties will continue to monitor events and provide their input, comments, and suggestions as we continue to finalize this development.

I appreciate the many residents who have participated in the process in so many ways. This has been especially difficult for residents who have for so long enjoyed the view of the mountain and are experiencing deep sadness over the changes that have and will continue to occur. It's always difficult to come to terms with change, particularly when it is change that strikes at long standing feelings and emotions. City officials greatly appreciate those of you who have taken the time to educate yourselves on the matter, to understand why these things are occurring, and to learn what can or can not be done about them.

Please be assured this development will proceed in full compliance with city laws, and that even the MOU does not permit the city to break its own laws. We are receiving and heeding continual legal advice. We fully intend to keep all of our commitments to Dr. Gibby which are outlined in the MOU, and look forward to his fulfillment of his commitments to us.

I hope that as questions continue to arise that you will all feel free to contact either myself or any appropriate city official to get the information that you need to be comfortable with this process. I also encourage all of you to stay in touch with the process and give us your insight and opinion when you have the opportunity. Several residents have stepped forward with offers to assist in delicate negotiations or other matters and we particularly appreciate them and their efforts. It is gratifying to see so many take the time to understand and contribute to the resolution of this situation. I hope we continue to try to help each other through this so that we can look back at these events with full understanding, not regrets or misgivings.

In order to hear further comments and answer your individual questions about this matter, as well as any other city related issue, including our current financial position, there will be a public meeting on Wednesday, January 14, at 6:30p.m. at the Community Center. I am very anxious that everyone have access to all the information and hope that as many as possible will attend this meeting. Please also accept our very best wishes for the holiday season. Thank you to those many of you that gave of yourself and of your means during this difficult time to make someone else's Christmas brighter and better. And, while waiting for those better times, it is my hope all of our residents will continue to look out for each other and be aware of the many needs around us and take every opportunity to spread good will and cheer throughout all of 2009.

For emergencies after hours, 4:30pm-7am on weekdays and on weekends, call (801) 489-9421. Mapleton Public Works emergencies are dispatched through Springville City Dispatch. Please state to dispatch your name, address, phone number and the type of emergency as this is relayed to the person on call. The Public Works has at least one person on call for after hour emergencies to cover the needs of the residents. They will assess the problem and if necessary, repair the problem immediately.

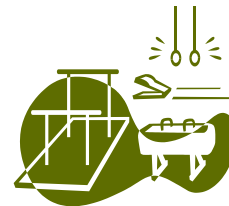

Plan to Minimize 400 South Closure Impacts

Allow yourself time to get where you need to go!

As this was going to press UDOT officials were planning to close Springville's 400 South between Main Street and 1750 West early on Monday, January 5, 2009 in order to begin 11 months of construction.

UDOT officials are hopeful that Mapleton and Springville residents planned which routes they will use to get to and from the SR-77 (400 South) freeway interchange and the business district around the interchange, both of which will remain open during the construction period. But even if they DID plan their routes, it's likely there has been some confusion during the first few days of the closure.

"It usually takes a couple of weeks for people to settle into detour routes that work for them," said Bryan Adams, Project Director for the SR-77 construction project. "You'll try one route, and it may be too crowded, so you go try another. After a couple of weeks things settle into a more normal flow as people get comfortable with the routes they've chosen."

The most important part of any construction coping plan is allowing yourself plenty of time to get to where you need to go, Adams said.

While the SR-77 freeway interchange is being reconfigured as part of the SR-77 project, the new Single Point Urban Interchange (SPUI) configuration fits snugly within the existing diamond interchange. So it is possible to maintain current traffic patterns on the interchange while working on the new SPUI. Still, Adams noted that there will be times when there will be only one lane functioning on the interchange, with flaggers allowing traffic to cross through the construction zone carefully.

Motorists should also be aware that 750 West and 950 West will remain open as much as possible during the construction period to allow north-south access across 400 South.

"We're doing everything we can to reduce the difficulty for motorists in the area," Adams said. "The good thing is, this closure will allow us to complete work on the project about seven months faster than if we had tried to maintain traffic through the construction zone. And when it's done you'll have a beautiful new five-lane road to travel, and two brand new bridges over the railroad tracks. It will be worth the hassle, I really believe that."
